### 1. Manager Report

Cailin Jope reports that the manager's summer hours will be changing to 4, 10-hour shifts with both managers on-site on Saturday. The pier opened on May 9th and the pool opened on May 23rd. Online reservations have been implemented for lap swimming and the hours for swim lessons have been extended on weekdays. The lower tennis courts will be restriping from June 6-10 and pickleball lines will be added to Court 1. Two members have not paid their dues and hearings for both members will be scheduled.

### 2. Tennis

Following the restriping of the tennis courts, pickleball will be moved from Court 3 to Court 1. Soundproofing a tennis court for pickleball is expected to cost between \$20,000 and \$30,000. The Tennis Committee has not expressed interest in spending the money for soundproofing. Two complaints were received prior to moving pickleball to Court 1 but the office will monitor member reactions to pickleball on Court 1.

### **3.** Nominating Committee

Jim Donahue and Scott Rodda interviewed Roger Quinlan and recommends him for nomination along with the three incumbents. A motion was made to approve Roger Quinlan, Nate Walker, John Casaudoumecq, and Jim Kelly for nomination. Motion seconded. Motion approved.

### 4. McClintock Audit

McClintock finished the draft financials for 2021 and the financials will be distributed to the Board by email for approval.

### 5. New Business

Nate Walker reports that the Dumpster Day turnout was similar to last year and the final Dumpster Day will be on July 29th. Firewise was able to receive a grant from North Tahoe Fire and the dumpsters for all Dumpster Days. Nate Walker would like to send a thank you letter from the Board to Doug Greenwood for allowing Dollar Point to use his photos on the website.
