# **President's**REPORT

Greetings from beautiful Dollar Point! Inside this newsletter you will find an important notice regarding additional Bylaws changes (which will be voted on at this summer's Annual Meeting in July), several informative committee reports, and important dates to remember.

Winter wasn't very "wintery" this year, but summer will bring several exciting additions and improvements to our facilities.

One of our biggest improvements is the pier, which has been updated with adjustable landings. These landings can be raised and lowered to accommodate different lake levels (which will be particularly useful this year!). The landings are wider, are accessed by a ramp instead of stairs, have more room for boats, and have dramatically improved the usability, safety and looks of our pier. A big thanks needs to go out to Steve Snow, one of our board members, who's been working on this project for the past few years. It's great to finally see the results of all his hard work!

You'll notice other changes at the beach: an improved pathway to the pier, repairs to the retaining walls near the barbecues and two new paddleboard racks! Due to the light winter and lack of run-off, the lake is nearly two feet below the level it was at the start of last season. Members are reminded to be especially careful when swimming around the pier area and docking their boats.

Kerry Bannon is rejoining us for her third year as Recreation Supervisor, and she is in the process of hiring the necessary staff and getting everything ready to go on opening day on Memorial Day weekend. Some of you may have seen Peak Landscape employees working around the pool area, making us look beautiful for summer. Special thanks to Sky Richardson, who has volunteered his time and expertise as liaison to Peak for many years.

No President's Report would be complete without thanks to my fellow board members

for their hard work: Pat Cala, Doug Greenwood, Steve Owles, Steve Snow, Lynn Thompson, and Carol Wilmar. We have a terrific board, all of whom have worked many hours to make Dollar Point Association one of the best! Of course, we all know that we could not function without manager Debbie Wolf, who is the "go-to" person for all of us, board and homeowners alike.

We have lots of news and changes to report regarding the pier, buoys and beach at Dollar Point. A greatly improved pier, new paddleboard rack and, unfortunately, an unusually low lake level awaits all of us this summer!

After many years of planning, discussions, and work, the pier improvements will be completed this summer. Although, only a few rules for use will change, the pier should now be more accessible for everyone: boaters, swimmers, strollers, etc.

Once again, this year, due to high demand we had to hold a lottery for the boat buoys. While everyone got their first choice, not everyone was successful with their second choice. There is a waiting list for BOTH sessions. Therefore, it is extremely important that if you are not going to use your assigned buoy for a period of at least one week, please notify Debbie in the main office. She will make an attempt to contact those on the waiting list and will then be able to rebate you some of your money.

As always please check your mooring lines and make sure they are the correct length and condition. Although, the rowboat to access the buoys is available at all times, the Boston Whaler will only be available as posted and, WEATHER PERMITTING. Please plan accordingly. With the pier improvements, we can now have three times the number of boats tied up to the pier catwalks, but please be respectful of your neighbors and do not leave a boat unattended, or tied up for more than 10 minutes. More than ever, due to the unusually low water, please exercise caution for rocks, swimmers, and the unknown.

It is important not to prop open the gate from the parking lot to the beach. It damages the mechanism and is expensive and difficult to repair.

The kayak racks have been repaired and aligned. Please note as they are strong enough to hold a (one) kayak per slot they are not designed to support the weight of a person. Please do not climb on them. For the first time in our history, we have had requests for more kayak storage than we have space. We will try to accommodate everyone this year, but there may be a limit set for next year.

There are new racks for at least 40 Stand Up Paddleboards. The response for use this first season is amazing. They are now all full and we have a waiting list for them as well.

Boats, boards, kayaks, and all equipment should be kept secure and safe in their proper prearranged and designated spaces. For example, SUP fins, if left on your board should not protrude into your "neighbors" space.

We are sorry to report that due to the extremely low water this year the swim platform will not be available. Unlike the water, vandalism and theft seems to be on the rise at Dollar Point. Please get involved in helping prevent any problems. If you see any actions that appear suspicious, take a photo, ask questions, and immediately notify an employee and/or the office.

Thanks again, to a great staff we should have a safe, exciting and fun summer. If you have a moment please let the staff hear your appreciation, they do work hard to make us happy! Have a great summer, and safe water play!

Placer County also enforces a leash law, so keep your dog(s) on leashes when walking in the neighborhood.

# **Defensible Space**

We want to thank those of you who have taken steps to provide defensible space around your homes. As you know, this is an important project and requires all of us to "chip" in!

There many free resources in North Lake Tahoe to create defensible space around our properties. The North Tahoe Fire Protection District provides many services including: inspections at your home, rebates, curbside chipping and green waste removal. The website is very informative and we encourage you to take a look at www.ntfire.net. The phone number is 530-584-2322.

The TRPA encourages the use of defensible space, tree removal, and erosion control to help make our community safer and to improve the clarity of Lake Tahoe. You can also visit www.tahoefiresafe.com for additional information for defensible space and erosion control measures which are required for your Tahoe home.

#### Some of the most important steps you can take are:

- 1. Thin your Trees You can remove trees on your property that are less than 14 inches in diameter without a permit. After the 2007 Angora fire TRPA increased the size from 6 inch trees to 14 inch trees. Lakefront homes are subject to special requests and permits. Request an inspection from the local fire district to find out if you should remove any trees on your property.
- 2. Trim Low Limbs and Thin Brush Low limbs and brush create "ladder fuels" allowing fire to travel along the forest floor and into the forest canopy. Manzanita is highly flammable and should be thinned and cleared. Fall is the best time to cut, trim and clear.
- **3. Rake Your Pine Needles** in the spring, let them fall in the fall.
- 4. Maintain a Non-Combustible Zone Keep a 5 ft. fire safe buffer free of combustible material around your structures.
