Firewise 2021 Certification – Need Your Help

Congratulations to all on the 2020 Firewise certification. The certification recognizes our community for fire safety actions, education, and community participation. Dollar Point is one of only 3 communities within the Tahoe basin to achieve Firewise certification. The two others are Carnelian Woods Townhouse Association and Lower Montgomery Estates located in South Lake Tahoe. Outside the basin certified communities include Alpine Meadows, Northstar, Lahontan, Martis Camp, Schaffer's Mill and Tahoe Donner. Why Certify for Firewise Each Year?

- Increased awareness of wildfire impact on our community
- Reduction of combustible fuels in Dollar Point
- Community engagement and education on fire safety
- Preparation for a wildfire event
- Fire insurance discount (select carriers recognize certification)

What's Required to Recertify?

- Update our 3 year plan
- Educational outreach within the community (including events, newsletters, etc.)
- Vegetation removal events and volume metrics
- Risk reduction investment to reduce fire fuel and hazards

We Need Your Participation with Metrics

We are now tracking the vegetation removal events (Dumpster days) and associated volume removed. However, we need your help with metrics on direct costs paid and any volunteer hours

invested in reducing fire risk. Such items would include vegetation/needle/pinecone removal costs, dumpster days, hydrant painting, shake roof replacements and association property clean-up. Firewise USA uses this info to measure community involvement and community ranking for grant money via NTFPD for fire safety programs. For example, grant funding this year is helping to reduce the DPA cost for dumpster days. Yes, this means you can help us find more funds to improve our fire safety.

Need your help with the following information:

- 1st Dumpster day – we missed the opportunity to collect this info during the event
- Remaining dumpster days – we will be collecting info at the 2nd and 3rd dumpster days as members drop off material
- Hydrant painting – we will be collecting info at the event
- Shake roof replacements – we will be collecting info later in the year
